QUALIFICATIONS FOR MEMBERSHIP

Corporate Members

Corporations that own or operate underground or submerged utilities or facilities.

Political Entities

Owner/operators of underground or submerged utilities or facilities that are governed either by elected officials or appointees of elected officials.

Sustaining Members

Individuals or businesses who share our interest in public safety, but do not own or operate underground or submerged utilities or facilities.

Mapping Requirements

Louisiana 811 uses a computerized mapping system to keep track of member underground or submerged utilities or facilities. For this reason, completed mapping information is a requirement for corporate members and political entities. Please complete parish checklist on the following page.

Dues and Fees

Corporate members and political entities pay \$100 in annual dues. The cost per notification is \$1.00 for corporate members and 80¢ for political entities.

Members who receive notifications **by fax** will be charged an additional 50¢ per notification.

Sustaining members (those without underground or submerged utilities or facilities) pay \$200 in annual dues to help promote the program.

Receipt of Notifications

Members must provide an email address or a dedicated fax number for use in conjunction with LA 811. If a member chooses to use a fax machine, it must be used for data transmission only -NO VOICE-
